### GOOD OF THE ORDER

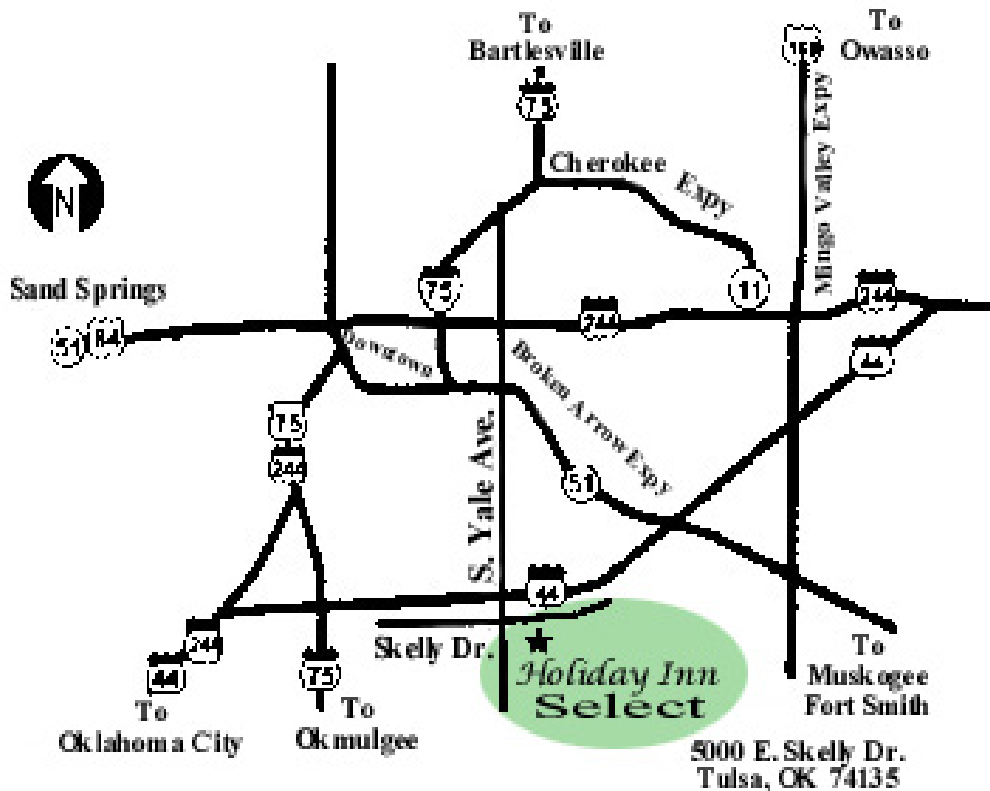

**SPECIAL NOTICE**

Our own Laurie Simon will be presenting a special program on the History of Locksmithing and his family's part in it starting with his grandfather in Chicago, via a Freelance Graphics presentation immediately following the general business meeting. This is a very interesting and many times funny look at how far Locksmithing has come in 120 years or so. There will be lots of pictures and stories for all to have fun with. It's one of the best times you'll have this year.

**We will be needing several volunteers to assist at these meetings as we'll be helping several applicants, so please contact Charles as to when and where you can help. The Alarm folks have indicated they will be assisting also.**

The amended rules for the Alarm & Locksmith Industry Act have been approved by the Oklahoma Board of Health and Governor Henry signed them December 21st. Once the Secretary of State posts them, they'll be forwarded to the State Board of Health.

The Oklahoma Department of Health will be mailing out the packets beginning the first of January, 2007. If you have not received the packet by mid January, 2007, contact us or the Health Department so the packet can be sent out to you. We've tried diligently to include everyone, but have no doubt we'll miss someone, so heads up and be watching. Plan on attending whichever meeting best fits your needs. We've tried to spread the meetings out to accommodate as many folks as possible.

**Each meeting location will consist of the following:**

A welcome area at the front; a photo area for pictures; an area for one-on-one assistance in filling out and verifying the application and supporting documents and notarizing the applicant's signature; a fingerprint area where the completed prints (and rest of the application & documents) will be sealed and given over to State custody; and a voluntary presentation by Matt Schue explaining the information the State expects each locksmith to provide the Inspector during any routine inspection once the individual is licensed.

Applicant must provide evidence they were engaged in Locksmithing, electronic access control, nurse call, or closed circuit television prior to January 1st, 2007.

**Examples of evidence include but are not limited to;**

- (A) Invoices for work performed.
- (B) Purchase receipts for industry related equipment.
- (C) Documents of installation or services by employees.
- (D) Other documents as approved by the committee.
