The first locks that we know of date to the ancient Egyptian culture, some 4,000 years ago, and the oldest locks featuring keys were made in 704 BC. Perhaps the most abundant time period for lock and key development was in the Ancient Roman culture. During this time, the Romans made locks out of iron and bronze. Often, they would create key handles with incredible detailing and design work. The more elaborate it was, the more likely it was your family was wealthy. Lock and keys were also a sign of wealth throughout Egyptian culture.

Rep. Kevin Wallace (R) Lincoln County—Has a bill to offset the Universal Licensing Recognition Act presented by Sen. Pugh last year. This new bill clarifies many of the industries concerns with the original ULR Act. Many of us are looking closely at this language to be sure that we can live with the end results. This bill will be presented in the 2021 session in the House of Representatives if the Senate again puts up the ULR Act. The hope is that the House bill will advance faster and will be accepted by both houses.
